<u>Down Payment</u>: A minimum of **50%** down payment is required to hold your date (excluding deposit). The balance is due 30 days prior to the event. In the event of a cancellation, rental down payments are non-refundable.

<u>Security deposit</u>: A Security deposit of \$200.00 is due 30days prior to your event and is refundable 48 hours after event as long as there is: no damage to the premises, no items or furnishings damaged or stolen, the Iva May is left in a clean fashion with all trash in trash bins, all decoration removed with no damage to walls or fixtures. In the event of a cancellation prior to the event, the deposit will be refunded in full. Deposit may be picked up after 48 hours of event, or will be mailed back in two week time frame.

<u>Cancellations</u>: The Iva Mae will only refund the security deposit (If it has been paid) if your event is cancelled for any reason. A full refund minus a \$100 Administration fee with be given if your event date is re booked by another party. The down payment can not be credited for a future date in the event of a cancelation.

<u>Clean up</u>: Cleanup will be done by Iva Mae staff however, renters must have trash picked up and placed in trash bins, all decorations must be taken down with no damage to walls or fixtures, and all personal belongings removed.

Smoking: The Iva Mae is a Non-smoking facility and under no circumstance will it be allowed to smoke, or vape inside venue. If this policy is violated and continues after addressed with renters and or guests event can be cancelled with no refund.

<u>Duration of the event</u>: The event hall can be accessed at 9am on day of rental. **The day prior may be rented and utilized for only additional \$300 dollars if available**. Agreed upon rental price includes facility from 9am to 12am, however **The Iva May can be used after 12am with additional fee of only \$75.00 each additional hour**. The building must be vacated and cleaned by allotted time (Breakdown/cleanup) in order to avoid additional charges for going over time.

<u>Prohibited items</u>: No Firearms, Fireworks, Sparklers, or illegal drugs may be used or possessed on or around the premises. This could lead to cancelation of event with no refund or legal involvement.

Refunds: In the event of circumstances beyond the control of the Iva Mae that render the premises unusable (Fire, natural disaster, power failure, ect) that would cause the cancellation of your event, your rental fee would be fully refunded. However the Iva May, or owners of the establishment can not be held liable for any compensation to the renter for the caterer, florist, musician, photographer or any other subcontractors.

<u>Damage from decorations</u>: The Iva Mae allows for decorations by renters, however, renters will be responsible for any damage to walls floors, carpet ect. Absolutely no tape, tacks, staples, nails, rice, or confetti, is permitted on the premises.

Children: If there are to be small children at the event we strongly encourage renter to designate someone to look after

<u>Lost or abandoned items</u>: Please keep all valuables with you at all times. The Iva May is not responsible for any lost or stolen items.

<u>DJ and Photo Booth</u>: Includes 5 hours of DJ service and 3 hours of photo booth service. **If more time is needed an additional fee of only \$50.00 dollars per hour of DJ service will be added or \$50 per hour of photo booth service added to total price.** The Photo booth can be customized to reflect your name and date. The photo booth includes one print for quests to take, and all pictures saved to USB drive for renter. **Additional pictures can be printed for only \$75 additional to total price**.

<u>Total price inclusions/exclusions</u>: Tables and chairs included in total price for total number of guests. However, **linens are not** provided by the Iva May **but table clothes can be rented for additional fee of only \$5.00 per table**.
